1-1 Content description

Statistical unit: this survey covers are registered entities in the Jordanian Union of Contractors.

The survey provides data on existing production, added value, workers compensation, depreciation, taxes, capital formation classified by economic activity and in accordance ISIC4.

1-2 variables

Main economic activity, governorate, production from minor activities, intermediate

consumption of goods and services, added value and its components (worker compensations, indirect taxes, depreciation, operational surplus), number of workers, number of entities in the sector.

- ISIC4
- CPC (central product classification)
- Published tables are based on ISIC – compliant data

2- Time

The survey is conducted annually, covering the data for the fiscal year prior to the survey year

3- Accuracy

3-1 overall accuracy

Very high

A stringent process is followed to ensure data accuracy:

- Field auditing of all questionnaires
- Auditing all variables in the questionnaire at the directorate
- Electronic auditing on computers
- Auditing data entry process through screens available to supervisors
- Auditing tables and comparing them to the output from IT directorate
