Survey sample: A stratified sample of economic establishments was drawn according to the international classification of industrial activities, distributed according to the geographical division in the Kingdom into three regions, and then the society in each region and economic activity was divided into five categories: Class (1) workers in the establishment 5 or less, class (2) Workers in the facility from 5-9 workers, category (3) workers from 10-19 workers, category (4) workers with 20 workers or more, category (5) rare establishment.
